NOTES ON AUTHORS

OSWALDO PORCHAT PEREIRA was professor of philosophy at the University of São Paulo (USP) from 1961 to 1975. He later taught at the State University of Campinas (Unicamp) from 1975 to 1985, and then again at the USP from 1985 to 1998. He is the author of A Filosofia e a Visão Comum do Mundo (together with Bento Prado Júnior and Tércio Sampaio Ferraz), Vida Comum e Ceticismo, and Ciência e Dialética em Aristóteles, as well as of several articles on epistemology (some of them published in Manuscrito). In 2001 he received the honorary title of Professor Emérito from the Faculty of Philosophy, Letters and Human Science (FFLCH), of the University of São Paulo.

GLENDA SATNE is professor of logic in the Faculty of Philosophy and Letters at the University of Buenos Aires (UBA), and research fellow of Conicet. She is the author of several articles, among them "Una defensa de la justificación etnocéntrica" (in Dianoia). She is also member of the organizing committee for the Wittgenstein Workshops in Buenos Aires. Her main fields of interest are philosophy of language, semantics and logic.

LUIZ HENRIQUE DE A. DUTRA holds a Ph.D. in logic and philosophy of science from the State University of Campinas (Unicamp). He is currently professor of philosophy at the Federal University of Santa Catarina (UFSC), and research fellow of the CNPq. He was visiting scholar at the University of Paris 7 (from 1994 to 1995 and from 2001 to 2002), and at the CLE, State University of Campinas (2001). He is the author of several articles, including "Réalisme et Fictionalisme chez laude Bernard" (Dialogue, 1999), and of some books, including "A Epistemologia de Claude Bernard" (Coleção CLE, vol. 33, 2001). She is a member of the Spanish Society for Analytic Philosophy (SEFA), and of the Committee for Ethics of Scientific Research of the Institute for Scientific Research of Barcelona (IMIM).

MARINA VELASCO is professor of Philosophy at the Federal University of Rio de Janeiro (IFCS/UFRJ). She holds an undergraduate degree in philosophy from the University of Buenos Aires (UBA), and a Ph.D. in philosophy from the Federal University of Rio de Janeiro. She is the author of Ética do Discurso. Apel ou Habermas? (Rio de Janeiro, Mauad, 2001). Her main fields of interest are action theory, ethics, political philosophy, and philosophy of language.

SILVIO SENO CHIBENI is Professor Assistente in the Philosophy Department of the State University of Campinas (Unicamp) and member of the Centre for Logic, Epistemology and the History of Science at the same university.
